2012 LWVKA Voter Registration Campaign Report

The dry facts of the League's voter registration activity in 2012 are as follows:

Twenty League members assisted about 250 potential voters in accurately filling out applications at 17 different sites. Also five members shared a rotating schedule of two-hour voter registration shifts each Tuesday at the Department of Human Services in Kalamazoo.

Here's what made achieving the above fun, interesting and worthwhile:

- Answering questions and correcting misinformation.
- Sharing the interest and excitement of young and more mature citizens planning to vote for the first time.
- Cooperating with and providing a needed service with the organizers of each event.
- Meeting with and interacting with all who wanted to register or who wanted to check current registration. Interacting with some who didn't want to be bothered was also interesting.
- Conveying to each possible voter that we, the women and men representing the LWV, think each of them should take advantage of their right to vote.
- Reminding people to check out the *Voter Guides*.

Take the time today to login in and join the discussions on the League Forums.

1. Like the discussion lists, the League Forums provide an opportunity to interact with fellow League members on specific topics and to share experiences and tools.
2. The Forums' notifications system allows you to decide if you want to follow a group (topic), a single discussion within a group, or even just a single person.
3. All messages are archived online for future reference.
4. You can easily build and manage your own personal profile.

League Urges Obama Action on Climate Change

On Saturday, January 5, 2013, the League ran a full page, color ad in the *Honolulu Star-Advertiser*, urging **President Obama** to set tough standards for new and existing power plants under the Clean Air Act. The ad is part of a broader push by LWV for executive action on climate change and is a follow up to a letter sent to the White House in December. League Urges Senate to Ratify CEDAW

The League joined over 100 organizations in sending a letter to the U.S. Senate urging ratification of the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW). CEDAW is a landmark international agreement that affirms principles of fundamental human rights and equality for women around the world.

League Sends Letter to VP Biden Regarding Gun Control

On January 10, the League sent a letter to **Vice President Biden** urging him to propose common sense solutions to the gun violence plaguing our nation. The League advocates for measures that will ban assault weapons, place limits on magazine size, close the gun show loophole, and mandate annual reporting on gun violence in America. The

League Calls for Reform of U.S. Senate Rules

The League sent a letter to the U.S. Senate urging reform of the rules related to cloture and filibuster procedures. The League calls upon the Senate to rise above partisanship and reform the Senate rules to achieve openness, accountability, decision-making capability and effective performance.

US Supreme Court to Hear NVRA Sec. 5 case on February 27, 2013

The US Supreme Court will hear oral arguments on February 27, 2013, in a lawsuit that challenges a central provision of the Voting Rights Act – Section 5. The case, [Shelby County, Alabama v. Holder](#), is one of the highest-profile voting rights cases in decades.

League Asks Senators to Oppose Changes to Contribution Limits

The League joined coalition partners in sending a letter to the U.S. Senate. The letter calls on the Senate to oppose efforts to restore the party soft money system. It also asks the Senate to oppose increasing the limits on the aggregate amounts that an individual can give to parties or candidates.

Voter Registration Modernization in the Spotlight

The Brennan Center for Justice held a panel discussion on voter registration modernization this week in Washington, DC. with Secretaries of State from MN, ND, NV and OR who discussed the need for on-line voter registration modernization. In conjunction with the panel discussion the Brennan Center also released a new publication – [The Case for Voter Registration Modernization](#). Registration modernization is one of the four pro-voter reform issues the League has identified as priorities this year at the state and federal level.
