

## President's Column

LWVKA poll observers wanted! Join League of Women Voters volunteers from around the country in monitoring the process at a local polling place for just 2 hours on Tuesday, November 8th. Is democracy working there? Check the accessibility of the polling place. Track wait times. See how poll workers handle voters who offer no photo identification. What happens if the voter's name is not in the poll book? If a voter's rights are violated, the League volunteer calls an 800 number to report it. No confrontations with poll workers or political party representatives. The role of a League poll observer is simply to observe and record those observations on a form. Interested? Contact Paula Manley (pjmanley@hotmail.com) or me (denise.hartsough@gmail.com). LWVKA will train you and give you a shift at a polling place where voters may face barriers to voting.

The League is dedicated to ensuring that all eligible voters – particularly those from traditionally underrepresented or underserved communities, including first-time voters, non-college youth, new citizens, minorities, the elderly and low-income Americans – have the opportunity and the information to exercise their right to vote. Poll observation, part of the League's Public Advocacy for Voter Protection project, is one effort to protect voting rights.

You may wonder why we need a special project to protect voting rights. To understand the origin of the Public Advocacy for Voter Protection project, we have to go back several decades. The League and its partners lobbied hard for 5 years for enactment of the National Voter Registration Act of 1993, commonly known as the "Motor Voter law." The law allows people to register to vote at motor vehicle agencies (Secretary of State's offices in Michigan), as well as at public assistance and disability agencies. The law also requires that states offer voter registration by mail-in application. This law makes it easier for all eligible voters to register.

Registering is one thing; voting is another. In the aftermath of hanging chads, long lines and other problems with the 2000 election, the League pushed for enactment of further improvements with the Help America Vote Act of 2002. This federal act helped states update voting equipment and create computerized statewide voter lists. Importantly, the act also established provisional voting as a nationwide right. If a person shows up at the polls on Election Day and claims to be eligible to vote, that person is permitted to cast a provisional ballot. Then, if voting officials determine that the person is qualified, the vote is counted. If not, the vote is disallowed. The act requires that voters be able to find out easily after the election whether their provisional ballot was counted or not, and why.

Implementation of the Help America Vote Act has not always honored the spirit of the law. Many states have used the statewide database requirement to create barriers to voter registration, barriers that strongly affect citizens who have historically been marginalized in the political process. A 2004 LWVUS survey as well as many lawsuits prompted better compliance with the law. Despite the progress, some states have continued to enact restrictions to voting.
